The use of the surgical microscope, bipolar cautery, the availability of the ultrasonic surgical aspirator, neuroanaesthesia, neurosurgical intensive care and neuro-imaging technology, Stereo tactic and minimally invasive neurosurgery, Trans sphenoidal surgery for pituitary tumor, spinal fusion for congenital and traumatic (CT scan & MRI for locating the target for functional neurosurgery) and intra-operative monitoring for different kind of surgery have revolutionized this super specialty.

Following shall be the requirements for this department

1. Neurosurgical and Neuro Anesthesia team, neurosurgical intensive care unit, intraoperative electrophysiological monitoring for spinal surgery.
2. Diagnostics with computerized Tomography (CT), Magnetic Resonance imaging (MRI) and angiography. All routine X-rays and ultrasound investigations.
3. Operating Rooms with preferably laminar air flow system and equipped with the ceiling mounted microscope with in-built still photograph and video recording facilities, capable with the optical tracking systems (OTS). OTS allows the monitoring of the progress of surgery in real time and residual tumors, hemorrhage etc. can be seen.
4. Intensive Care unit equipped with the latest modular invasive monitoring system (HP) and advanced life support equipment capable of managing complicated neurosurgical and neurological patients effectively. The nursing ratio is one to one. All associated specialists like respiratory physicians, nephrologists and endocrinologists like respiratory physicians, nephrologists and endocrinologists should be available round the clock.



fractionated treatment (stereo tactic Radiotherapy —SRT) for benign and malignant tumors not suitable for SRS.

Computer Assisted Neurosurgery, operating computer with an accuracy of 1 mm in which images of the patient's brain can be directly transferred from the MRI or CT Scan to the Operating Table. The surgeon can join the probe to different parts of the brain and retrieve the images previously taken. This is of great help not only in locating difficult tumors, but also in avoiding critical structures and ensuring completeness of excision. Surgery for abnormal movements, epilepsy and small deep malformation can be done.

Frame based Stereotaxy, Radionics, CRW systems complete with full range of accessories to include the ability to carry out frame based stereo tactic Surgery including Craniotomies. Equipment to generate RF lesions, for functional neurosurgery procedures like pallidotomy and thalamotomy for treatment of movement disorders and Parkinson's disease. Image guided Frame less stereotaxy allows surgery in eloquent areas.

Interventional neuro Radiology. A separate Department and separate machine should be available for this crucial area. A machine with biplane rotational angio facilities is utilized embolization of arteriovenous malformations, treatment of g....aneurysms by proximal occlusion and endovascular packing used GDC system, Thrombolysis by injection of Urokinase directly thrombus in the specific artery in the treatment of brain attack Angioplasty and stenting to prevent stroke, treatment for Vasculopathies such dural AV malformations carotid-cavernous fist...hemangiomas of the head and neck, vascular tumors.

Microsurgical Instruments :

Neuroendoscopy equipment for minimally invasive endoscopy removal of certain tumors (e.g. intraventricular and pituitary tumor third ventriculostomy in the treatment of hydrocephalus, drainage brain abscesses angiomas).



for stabilizing the spine using metal implements. These are used in cases spinal injury, Tuberculosis and tumors. This allows early ambulation, facilitation, rehabilitation and early discharge from hospital.

Department of Pathology :

Hisopathology, Cytopathology, electron Microscopy, Haematopathlogy, Clinical Chemistry, Endocrine Pathology, gastrointestinal and Hep..... Cosmetic surgery to reshape normal structures of the body in order to improve the patient's appearance and self-esteem, treatment of skin diseases, cancer, trauma, complex wound and burn treatment, Surgery of the breast, Treatment of facial deformity, disease, trauma, Surgery of the hand, Surgery of the trunk and extremities, Cosmetic surgery.



Characteristics of Market

India has a fairly extensive healthcare structure that caters to the needs of the vast population. In 2007 estimates of the Indian healthcare infrastructure put the numbers of doctors at 10,00,000 nurses at 900000 and hospitals at 25000 and hospitals beds at 25000 medical colleges in India 2007 numbered around 190, with approximate 20000 doctors graduating every year.

The decade has seen the growth of corporate and privately run hospitals in India accompanying growing demand for higher standards of healthcare. Small hospitals (4-50 beds; often called nursing homes) and large hospitals constitute the private sector.

Many government run hospitals suffer from shortages of trained professionals, equipment and consumables.

India's healthcare industry is worth Rs. 93,000 crore today roughly 4% of the country's gross domestic product. Knock off the entire Pharmaceuticals business from that many regard drugs as separate industry to focus purely its on things like hospitals, health insurance, managed care, still this is a Rs.81,000 crore industry. That's equal to the turnover of the country's 12 largest private sector companies including Reliance industries, Hindustan Lever ltd.(HLL) and ITC: But that's just the tease. The real stuff, a heartbeat away, is what Asian Health's Bagaria has to say, and based on studies done by the Firm. India's healthcare industry is expected to grow by around 13% a year for the next six years. In other words, in between now and 2018, it can keep adding the turnover of the Rs.10000/- Crore HLL, each year. Throw Pharmaceuticals back to the pile and it could be adding the Reliance every year.

In fact, a few factors are expected to power India's massive healthcare engine. Since healthcare is dependent on the people served, India's huge population comes in handy. To grow the business by the estimated Rs.8000/- crore every year, per capital expenditure needs to rise by only Rs.80 a year from the current level of Rs.831. In fact most industry watchers feel this increase still won't take India anywhere near the per capital spends of even comparable countries like China (Rs.1640) or Brazil(Rs.12,747), forget the US(Rs.1.70 lakh) or Japan (Rs.1.22 lakh).

Dr. R.R. Kasliwal, Sr. Consultant (Cardiology), Escorts heart Institute & research Centre, New Delhi made a presentation on Meeting the Cardiovascular needs of people. Elaborating the scenario of the heart diseases worldwide via-s-via India. Dr. Kasliwal observed that the cases of heart diseases are very high in India. It occurs in nearly one-third of the patients who undergo bypass surgery, which is less than 13%. He stated that by 2017, 36% of all male and 33% of female deaths would be due to heart attacks and there would be an increase in CVD



make the people aware of the disease and prevent it from cardiac ailments and there is a large incidence of coronary heart disease. The prevalence of these diseases in India is very high 105.6 per thousand. The risk factors include high blood pressure, heredity, diabetes, obesity and sedentary life style. He also outlined few generic measures like less strain/stress, avoiding drinks, smoking and other kinds of anxieties and depressions to prevent the disease, for an improved quality and quantity of life in future.

Dr. Kasliwal urged for a national effort, particularly with respect to regional heart policy for the prevention of disease — mortality and morbidity, cardio-vascular risk studies, efficient system of surveillance, identification of other risk factors and determinants of health behavior in the society. He cautioned that by the year 2015, India is predicted to be a diabetes capital of the world. The need of the hour, he said is the community based program. Quality and quantity of healthcare should be our main motto, he added*(*Source:www.ficci-self.org)

Demographic Details

The demographic data available from NCAER, 2006. states that national average of proportion of households in low-income group (annual income <Rs.35000) has declined by 58.54% 2000 to 49% in 2006. 
